THE CLUB LORELEI::::: A LARGE stone BUILDING ON THE N.W. CR. BERTIE & CON.  
PROPERTY ORIGINALLY BELONGING TO JOHN B. HERSHEY. PART, OF THE FORT ERIE  
RACE TRACK. AT ONE TIME THE HOME OF Nancy WECTOR. SHE AND FANNY  
SOLD TO John Madigan around 1911. it went from Madigan to Gladys andrews  
widow . In 1946 she sold the old home to Ernest & Elly Born:J.T.  
In 1950 the Club Lorelei was opened in the building a drinking and  
gambling establishent, that was always being raided by the law/.Eventually  
the building was demolished.

There was also a farmhouse close to the Madigan home.
