beginning within one chain of the north east angle of lot # 16 on the Niagara River: thence west one hundred chains: thence north twenty chains: thence East to the River Niagara: thence South along the bank of the River Niagara aforesaid, to the place of the beginning: containing by admeasurement two hundred acres be the same more or less, together with all and singular the privilages and appurtenances whatsoever thereonto belonging: which said deed is witnessed by John Fanning of the Township of Stamford the County of Lincoln and Province aforesaid inkeeper: and John Pierce of the Township of Cornwall in the County of Litchfield in the State of Connecticut of the United States of America and is hereby require to be registered by me the said Christopher(Christian) Hershey, the Grantor and witness: whereby I have herein set my hand and seal at Stamford: the 4th, day of Jan in the year of Our Lord 1798.
