THIS IS THE LAST WILL AND TESTAMENT of me Henry Edward Miller of the Township of Bertie in the County of Wellands Farmer.

I revoke all former or other Wills or Testamentary dispositions by me at any time heretofore made and declare this to be my last Will and Testament.

I direct that my Executors hereinafter named shall pay all my just debts, funeral and testamentary expenses as soon after my decesse as may be convenient.

I hereby nominate and appoint my brother JOHN P. Miller of of the Township of Trowland, Farmer, and THOMAS MDWARD Miller of the Township of Bertie, Farmer, to be Executors of this my last will.

I further give and bequeath to my naphews WILLIAM FRANKLIN MILLER: BENJAMIN ANDREW MILLER: HARDING EDWARD MILLER and EDGAR MILLER my farm composed of the North part of Lot number Fourteen in the Fifth cencession from Niagara River in the Township of Bertie and Lot Number Fourteen in the Sixth Concession from Niagara River in said Township, Containing one one hundred and fourteen are River in said Township, Containing one one hundred and fourteen acres more or less to be divided equally among them Share and share alike.

IN WITHESS whereof I HENRY EDWARD MILLER the Testator have to this my last will and Testament set my hand and affixed ty seal this eighth day of February A.D. 1900.
