THERE PROPERTY ON STONEMILL RD. GRANTED BY NICHOLAS UEBELHOER:
Oct. 26, 1874.

" All and singular that certain parcel or tract of land and premices situated and lying and being in the Township of Bertie in the County of Welland, in the said Province: containing twenty-seven hundredth of an acre: being composed of part of the west part of lot number twelve in the second concession from Lake Erie in the Township of Bertie, more particularly described as follows: commencing where a stake has been planted near a walnut tree on the western limit of said lot at the distance of seventeen chains and twenty five links north, from the south west angle of said lot number twelve: thence east one chain and seventy five links to a stake: thence south one chain and fifty links to a stake: thence west bounded on the south by a parcel of the said lot conveyed to the Trustees of the Wesleyan Methodist Church, one chain and seventy five links: thence north to the place of the beginning; whereon a building for a church is now erected."
