Mr. Chairman, Ladies & Gentlemen, I should first like to thank Harold Ruch, who nominated me for this high office and Mrs. Dr. Hays who seconded my nomination - These citizens have already shown no great honour - I deeply appreciate it. It is not the least important of Political Offices, it is the most important - If the foundation is weak the structure will collapse - I believe it is the duty of every citizen to support that Covernment and to offer himself for plic Office if he and his fellow citizens feel he has something to offere I feel that the Office of Mayor requires the services of sincere, devoted and trained man - one trained not only in dealing with other Governments both Provincial and Federal but one who has the business background to cope with these affairs. I believe the Town of Fort Erie to be the most important entity in Canada, to be the symbol of the bases upon which all Governments are built. I believe I have those qualifications - That Is why I want to be Mayor of the Town of Fort Erie, my Hometown - I was born here, have lived here and now am raising my own family here. I have a very definite personal interest in the affairs of Fort Erie. During the past few weeks I have had the opportunity of speaking with meny of the good citizens of Fort Erie and you have impressed the wish and desire for many improvements - better streets, sewers, disposal, water filtration plant, new schools, new hospital parking space, municipal pool and recreation building, etc, etc and lower taxes. All these would indeed be wonderful but, I can not say to if elected, this will all be so, for after all, what does a Mayor do? For the records, what does the Mayor do - He not only acts as Chairman of a meeting understanding the rules of Parliamentary Procedure - He must not be opinionated -

an impartial way. - He must give guidance and direction to Council Members and what is most important he must see that all Delegations and persons wishing to be heard are heard in Council and Council renders its Decision as quickly as possible.

Again I refer to the duties of a Mayor - he must be able to hendle a meeting. It will be his responsibility to see that his department is run efficiently. The Mayor presides at these meetings, he must see that rules are followed - that the questions are discussed intelligently and answered. The Mayor must have a thorough knowledge of Parliamentary procedure; he must be firm in applying these rules; he must not allow meetings to got out of hand; he must guide, lead and direct and keep the discussion on the problem at hand until solved.

During Bill Houcks term of Office I had the privilege of helping many Citizens and delegations at his beguest with both Federal and Privincial Houses. I was able to see the working of the various Departments and let me say Ladies and Gentlemen a knowledge of the workings is a must for anyone who seeks the position of Mayor for Provincially and less so Federally you are daily seeking help from various Departments whether it is the Health Department, the Highway department or any of the other Departments. At this Time, I taught in the High Schools of Ontario for 5 years. At this point Ladies and Gentlemen. I stop for here is a training that may go unnoticed or you may feel unimportant. The Mayor is a Member of the Police Commission, as such like Ceasar's Wife he must be beyond reproach, in our Town the Chief difficulties of the Police are with the so called Juvenile Delinquents - having handled in my teaching career some 5000 boys and girls between the ages of 13 -18 I do feel the understanding and knowledge I had of the Boys and Cirls places me in an excellent polition to x give advice on the Commission.

In closing Ladies and Gentlemen, I ask for your support while I leave with you these thoughts My Dad started a Business and saw it Grow— It has had its setbacks— it has had its eversals by dint of hard work and application together, we have seen it prosper— If I did not know with the above qualifications I could do service to the Town of Fort Eric and fulfill my obligations to it, I would never have stood for the Office of Mayor— not because of myself but because of the honour and esteem in which I hold my Father's name—to me it is
