Shaw's eventually had this building removed when they built thier rest. addition to the Bakery bus. Samuel Roff Men's Furnishings occupied this building in the twentie. Mrs. Morton ran a tea room here in the late 30's early 40's. The Millar family lived in the apt. above. Eventually became the Parkviw Rest, and eventually demolished by Eddie Chew.
