

PROP OF HENRY WINDECKER LOT IE2 IGT CON UILLAGE OF WATERLOS - (FORT ERIE) HENRY WINDECKER::: lot # 2. con. 1. Niagara River.

May 6th., 1796.	Crown to Henry Windecker.
Aug.7th. 1796.	Henry Windecker to David Cowan
Nov. 12. 1801.	David Cowan to Benjamin Hardison.
May. 31. 1833.	Benjamin Hardison willed to wife

July. 18. 1833. Jane Hardison sold to Lewis Palmer, lot #2 among a tier of lots owned by her: more particularily described as being a part of lot # 2 in the first concession, in the Township of Bertie aforesaid: on the Niagara River.

> said Village lot is: butted and bounded or may be otherwise knownas the follows( that is to say) Commencing at the south east angle of Richard Thompson's lot, south Two and a half degrees: west one chain and twenty five links: then west two chains: then north two and a half degrees: east one chain and twenty five links. Then---. two chains to the place of the beginning: containing one fourth of an acre, be the same more or less.

## HENRY WINDECKER::: lot #2 in the 1st. con N.R.

Henry Windecker was a member of the Buttlers Rangers. 1797 he received from the Crowm 250 acres of land. He was recommended 400 acres Military lands and 350 acres family lands.

1797 Crown to Henry Windecker 150 acrs all of lot 2 con1 N.R. etc.

1799. B.&.S. David Cowan to Alexander Douglas Sr. 2 acres.

- Feb. being 1 acre, measured a square of equal sides in the n.e. cr. in the 1st. con., and also another acre, 1 assured in the same way immediately behind or to the west of the first mentioned acre. These two acres being bounded on the east by the main river; and on the north by part pf lot #3 on the property of Benjamin Hardison, and on the west and south by part of lot #2 being 416ft. on the north and south sides and 208 ft. on the west and east sides.
  - B.&. S. Benjamin Hardison and his wife Jane to Alexander Douglas 125. 3.26 parts of lot no 2. in the first & second con., a part of the said lands being described as follows::: commencing at a post on a west course at a distant, 7 chs. 7 33 links from the N. R. and the north eastern most---- of lot No.2 in con.1.: then west 9 chs. 81 links: thence 5 chs. 56 links: thence east 16 chs. 14 links: thence north 2 chs. 40 links: thence west 6 chs. 33 links: thence north 3 chs. 16 links to the place of the beginning.

Reg. May 1899. Agnes Douglas wills to her son Wm. Douglas the lands herein described; except the south 64ft. measuring from Niagara St. to Victoria wjich she willed to her son John Douglas: known as the Cottage Hotel.
